We are ready to sign the IIA on Dashboard, so we look forward to do that whenever your own system is fully operational to this purpose.

As regards the language requirements for students to easily access our courses, we would like to maintain the same as in the previous IIAs. The level of English required is B1, and the level of Romanian is A2 for Veterinary medicine and B1 for Agriculture. This difference in the Romanian level is given by the fact that Veterinary medicine is taught in English, but the Agriculture programme is only in Romanian. Please note that the incoming students attending our programmes in Romanian are fully supported by our professors.
