2. **RO IASIO3:** Nominated students receive by e-mail their login details to our online application form that they have to complete within the deadline above. Once completed, they receive an acceptance letter by e-mail within a max. of 6 weeks.

UK LIVERPOO1: The receiving institution will send its decision within 8 weeks.

- 3. A Transcript of Records will be issued by the receiving institution no later than 5 weeks after the assessment period has finished at the receiving HEI.
- 4. Termination of the agreement

Either party may terminate this Agreement by giving the other written notice before the start of an Academic Year which shall expire no earlier than the end of that Academic Year. Neither the European Commission nor the National Agencies can be held responsible in case of a conflict.

3. Insurance

The sending and receiving institutions will provide assistance in obtaining travel insurance, medical insurance (where necessary) and third party liability insurance for incoming and outbound mobile participants, according to the requirements of the Erasmus Charter for Higher Education. When acting as the sending institution, the University of Liverpool will advise outbound participants (staff and students) to obtain the European Health Insurance Card (where participants are eligible) and will provide its outbound participants (staff and students) with access to comprehensive travel insurance cover for the period of their time abroad. When acting as the sending institution, the University of Liverpool expects partners to have in place appropriate liability policies which will indemnify incoming exchange students if any loss, damage or injury is caused by or to them when acting under the partner's supervision or control. If the receiving institution is unable to effect such liability insurance, the placement could continue if it is a substantial institution with resources available to pay such liability claims in excess of EUR 5 million from its own resources.

The receiving institution will inform mobile participants of cases in which medical and third party liability insurance cover is not automatically provided. When acting as the receiving institution, the University of Liverpool will provide incoming participants with written guidance advising them to obtain the European Health Insurance Card (where applicable) before they leave their home country and comprehensive travel insurance cover for the whole of their stay in the UK. The University of Liverpool's liability insurance will indemnify incoming Erasmus students studying at Liverpool if any loss, damage or injury is caused by or to them when acting under our supervision or control up to an indemnity limit of £30m.

5. Use of University Names and Logos

- 5.1 In the context of the Institutions in this Agreement the circumstances where name and logo of one Institution may be used shall be subject to prior approval by the other. In the event of one Institution wishing to engage with a third party in order to market the programme, the Institution shall seek the other Institution's prior approval. All goodwill arising from the use of one Institution's name and logo shall vest in that Institution. Any use of one Institution's name and logo by the other shall cease on termination of this Agreement.
- 5.2 Each University shall require sight of all proof materials prior to publication.
- 5.3 The University of Liverpool and the partner university shall have the responsibility for accuracy in marketing, publicity and other promotional materials for this programme.

6. Dispute Resolution

The Parties agree that any dispute between them as to the intent or meaning of this agreement or the rights or obligations of any party shall if unable to be resolved by senior officers of both institutions be referred in the first instance to a private and independent mediation by a mutually acceptable suitably qualified mediator who shall assist the parties to reach an agreed resolution of the issue but who shall not be empowered to impose any resolution.
