The candidates are requested to submit:

- Application Form for Incoming Students, which must be signed by Erasmus coordinator of the sending institution
- Learning Agreement, which must be approved and signed by the relative departmental coordinator and Erasmus coordinator of the sending institution
- Transcript of Records
- Twophotographs

The necessary documents must be posted before the arrival of the incoming students to the following address:

The incoming students are obliged to inform the International Relations Office of Bilecik Şeyh Edebali University concerning their trip details to Bilecik in advance. In addition, the incoming students should contact the relative department of Bilecik Şeyh Edebali University.

After their arrival, The incoming students must apply to Foreigners Section of Police Headquarters for the residence permit. The incoming students have to get ‘Student Visa’ before arriving to Bilecik to be able to get residence permit. In addition to ‘Student Visa’; The incoming students have to hand 4 photographs to the Foreigners Section. The residence permit costs nearly 190TL (approximately 70 Euros).

2. The receiving institution will send its decision within **3** weeks.
3. A Transcript of Records will be issued by the receiving institution no later than **4** weeks after the assessment period has finished at the receiving HEI.
4. Termination of the agreement
This agreement can be terminated at any time by mutual consent. In the event of unilateral termination, a notice of at least one academic year should be given. This means that a unilateral decision to discontinue the exchanges notified to the other party by 1 September of one given year will only take effect as of 1 September of the next year. Neither the European Commission nor the National Agencies can be held responsible in case of a conflict.
